



## Music Rental Terms and Conditions

We rent all musical materials only for live performances and only for the number of performances stated on the rental invoice.

- Materials may not be used for radio or television broadcast, webcast, streaming or any usage other than live performance and/or archival purposes without separate permission in writing from Drapkin Music Publications.
- You must give credit to the arrangers and songwriters or composers (for purely instrumental music) in your printed or electronic program. In the case of the Nutcracker Ballet, anywhere the name "Tchaikovsky" is mentioned, you must append "Transcription by Michael Drapkin."
- You may not photocopy any of the materials without written permission.
- You may not lend, give or rent any of the materials to third parties.
- If delivery is made via PDF files, all files and printed copies of the files must be destroyed after the last concert.
- Payment is due in full before we send you the music. Payment is made through the NutcrackerTranscriptions.com website.
- Extended rentals are allowed only if requested within 2 weeks of the final performance. Extended rental requests must be made to us in writing.

### SHIPPING & MUSIC DELIVERY

- You are responsible for all shipping and handling costs, in addition to the rental fees.
- We'll ship your package anywhere that can accept deliveries.
- Shipment will be made upon receipt of funds.
- For rush delivery, select a higher class of shipping service at checkout.

### RETURNING THE MATERIALS

- You must return all the materials in the same condition as received within two weeks after your final concert or there will be penalties assessed.
- Return instructions are on the Inventory List included with the shipment.
- If any of the material is returned with markings rendering the material useless for rental, you will be charged the cost of replacement.

### CANCELLATION POLICY

- **Before we ship the score and parts:** No charge.
- **After we ship the materials but no later than two weeks before the concert:** A \$75 restocking fee plus you are responsible for the return shipping cost.
- **Cancellations due to weather conditions on the day of the concert or force majeure:** You must notify us by phone or email on the day of the performance. You have the option of leaving the fee with us as a credit for a rescheduled performance. If you want a refund, we will refund ½ the performance fee plus a \$75 restocking fee. You are responsible for the return shipping cost.
- **Cancellations for any other reason sooner than two weeks before the concert:** Since you are already in possession of the music, you have the option of leaving the fee with us as a credit for a rescheduled performance. If you want a refund, we will refund ½ the performance fee plus a \$75 restocking fee. You are responsible for the return shipping cost.

### MISSING MATERIALS

- If the rental set is missing a part, please contact us and we will email PDFs to you within 24-48 hours.
- If you lose any part prior to your performance and need a replacement, please send us an email and a replacement part will be sent to you as soon as possible. Replacement cost and shipping/handling fees will apply.
